Photoshop Elements. Next, click on the 'New' button on the top toolbar. This will open a new tool window called the Quick Palette. When you click on a thumbnail in the Quick Palette, a toolbar will appear under the workspace window. In that toolbar, you can click on the tools available to use on the selected image. You can also use the Quick Palette to open up any of the 32 palettes that you have created. Right-click on the thumbnail in the Quick Palette and select Open Palette. Photoshop Elements will open that palette and load that image into the workspace window.

You can use that palettes to edit any other image that you have loaded into Photoshop Elements.

**Editing Image Files** You can use any of the editing tools in the Quick Palette to edit a photo. To select a specific editing tool, click on the tool in the Quick Palette, drag it over the thumbnail in the Quick Palette and drop it on the workspace. The tools are organized into the following categories.

**Colors.** Use this tool to adjust any image's colors. You can use this tool to adjust

Brightness/Contrast, Exposure, Whites/Colors, RGB/CMYK, Grayscale, and Saturation. Each adjustment tool has a dialog box with various options. These hyperkeratotic keratotic papules were present on both palms and soles. We performed a biopsy of the lesion on her right hand, but the histology was inconclusive, as it demonstrated neither hyperkeratosis nor parakeratosis. She had a two-week history of repeated episodes of painful pruritus, and was referred to our dermatology department. On physical examination, the patient's family pedigree was typical of Hailey--Hailey disease (Figure 1). She also had a hyperkeratotic papule on her left knee. We performed a biopsy of the lesion and found that this papule was also typical of Hailey--Hailey disease (Figure 2).
